- (A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from any activity and/or event, THE FOLLOWING ENTITIES OR PERSONS: Surgamus Speech and Debate Club and First Baptist Church of Elkins and/or their directors, officers, employees, volunteers, representatives, and agents, and the activity holders, sponsors, and volunteers;
- (B) INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in any and all activities and/or events, whether caused by the negligence of release or otherwise.

I hereby consent to receive medical treatment, and I give my consent for medical treatment for any/all of my minor children which may be deemed advisable in the event of injury, accident, and/or illness during any/all activities and/or events associated with Surgamus Speech and Debate Club and the Christmas in the Ozarks Tournament.

The Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and

waiver to the maximum extent permissible under applicable law.
