



ORU Rules & Regs

Licensee and Licensee's Event participants must adhere to all University policies, regulations, guidelines, and all local, state, and federal laws concerning health, safety, and public order. Failure to comply with these regulations may result in forfeiture of the privilege of using University Resources or termination of this Agreement. University regulations include but are not limited to the following in University Resources and on University property.

A. All individuals will abide by Oklahoma law, federal law, and University regulations regarding intoxicants, narcotics, and drugs. The possession or consumption of beer, wine, or other alcoholic beverages, marijuana, or use of narcotics in any form is forbidden except the possession and use of prescription drugs by the person for whom it was prescribed.

B. Firearms, weapons, ammunition, fireworks, explosives, and highly flammable materials are strictly prohibited. Open flames of any kind are not allowed.

C. Any disruptive or damaging activity in the residence halls or anywhere else on campus is prohibited. No skateboard shall be used or balls thrown in the residence halls.

D. Bicycles are prohibited in student rooms, study rooms, or stairwells.

E. Animals are not allowed on campus.

F. Hot plates or similar appliances are not permitted in rooms, nor is cooking allowed in any room except kitchen areas.

G. Attaching any object to any University premise by nail, screw, tape, or glue, or alterations of the premises in any manner whatsoever without prior permission from the Department of Conference & Event Services is not permitted.

H. Parking is permitted in areas designated by the Department of Conference & Event Services. Parking in fire lanes or service lanes is strictly prohibited. Vehicles parked in non-designated areas will be towed at the owner's expense.

I. Tampering with or removal of windows or window screens from any part of any building is not allowed. Access to and or objects are not permitted on any dormitory balcony.

J. Tampering with the fire system or firefighting equipment is not allowed. A \$500.00 fine will be assessed to the Event for each time an alarm is pulled or \$250.00 for each fire extinguisher discharged.

K. Event participants in the residence halls are to enter and exit only through the front lobby doors except in the case of emergencies. The use of or unlocking of any other doors is strictly prohibited. Any use of fire escapes other than in emergencies will result in a \$100.00 fine.

L. Event participants should not enter floors, residence halls, or other buildings not assigned to their group.

M. Gambling or solicitation in any form is not permitted.

N. Event participants should keep all valuables on their person or locked in their rooms if keys are issued.

O. The University campus is private property. Any emergencies that arise (fire, theft, vandalism, etc.) must be reported to the Department of Safety and Security immediately (495-7750). Security will coordinate efforts with the necessary city departments and officials. Security must be informed of any time emergency personnel are present on campus.
